2.	Trustee Reorganization and assignments	Trustees selected new Chair and Vice Chair for 2017-2018 and assigned projects. Proctor nominated Patricia Hall to be the new chair for 2017/2018 King seconded, unanimous. King nominated Rod Spears for Vice Chair, he declined. Proctor nominated King, Hall seconded, unanimous.
