SGVMWD CONNECTION UPDATE

California Health department has given Water Superintendent Reynoso a verbal approval to begin using water from the SGVMWD connection, with the written permit amendment to be delivered to the City next week. We will hold off actually taking the water until Monday at the earliest; we want to have full water staff on site when we start taking the water, so that we can respond to customer inquiries and to ensure that the high level of monitoring that will initially be needed, is covered.

WATER & SEWER RATE STUDY

You will notice that the draft Water & Sewer Rate Study is not on the October 8th Council agenda. There was not adequate time to turn the report around after Monday night's Special Council meeting. The report will be on the Council's October 22nd agenda.

RHNA UPDATE

The Southern California Association of Governments is beginning the 5th Cycle RHNA process, and meetings of the RHNA and Housing Element Reform Subcommittee will are being scheduled. The first meeting is Wednesday, October 23, 2012 at the SCAG offices. The City Council SCAG Liaison and Alternate Liaison (Council Member Capoccia and Mayor Pro Tem Harabedian) will be meeting to

review the 4th Cycle process so that Sierra Madre can submit comments and recommendations early in the process. Staff will be returning to the entire Council, at an upcoming Council meeting, as soon as there is something to report.

LOCAL IMPACT OF FEDERAL GOVERNMENT SHUT-DOWN

We were notified this week, by the United States Forest Service, to close and lock the Chantry Gate at the top of Santa Anita Avenue. The Chantry gate will be closed until the Federal furlough is lifted. The road up Chantry is a popular destination, and on the occasions when we have had to lock the gate, we receive numerous complaints. We put the information on the City's Facebook page in an attempt to get the word out.

UPCOMING COUNCIL MEETING ITEMS

The scoping meeting will be held on October 15, 2013, at 6:30 p.m. in the City Council Chambers, to present the EIR process and to receive public comments and suggestions regarding the scope and content of the EIR.

IN 'N OUT READING PROGRAM

PUBLIC WORKS

CONSERVATION

To steal a phrase from another City program, "Sierra Madre Water customers Rock!" For the first two days of October, conservation over last October's use stands at 22%, with 1.5 million gallons saved.

STREET PROJECT UPDATE

The street project continues towards completion, with slurry seal and striping to take place on West Sierra Madre Blvd. this Friday night and Sunday night respectively. Work will start at 9 PM, with the boulevard completely closed to traffic between Baldwin and Lima. This scheduling is intended to minimize the impacts on the downtown business area.

Delays in completion of the ARAM overlay on Oak Meadow Road have caused resident concerns to continue. Observing the unfinished project, residents are concerned about the appearance, quality, and durability of the work that has been done. Staff has met with a group of residents at the site, and following that met with the design engineer, contract inspector, and construction contractor to devise a solution. Staff has attached a step by step illustration of the ARAM process on the following page in hope of reassuring the reader that the finished product will meet with everyone's approval.

CALTRANS NOTIFIES CITY OF FUNDING AVAILABILITY

Caltrans notified staff this week that federal funding that Public Works applied for in October of 2012 has been approved and will be available shortly. The funds total \$60,000 and come from the Federal Highway Administration for cleanup of arterial streets following the November 2011 windstorm. Staff will prepare and submit the next round off Caltrans applications for payment.
