CALL TO ORDER / ROLL CALL

Trustees Procter, Hall, King, and Ziff in attendance. Meeting called to order at 4:03 pm.

APPROVAL OF AGENDA

Trustee Ziff motioned to approve the agenda, Trustee Spears seconded. All approved.

APPROVAL OF MINUTES

Trustee Hall motioned to approve the minutes from the October 28 meeting, with one correction of the title of the City Treasurer from City Accountant. Trustee King seconded. All approved.

- **1. Library Warrants –** Trustee Ziff recommended that the Board approves payment of Library Warrants. Trustee Spears seconded. All approved.

1. Day Estate

Trustee Procter reported that he met with the Finance Director and the City Treasurer regarding the Day Estate Funds. The funds will be placed in a separate account with no comingling with other funds. The City Treasurer will research the most aggressive investment strategy that is available to the City, per the trustees request.

2. Emergency Digital Materials Grant

City Librarian Smart discussed a \$5,000 grant the Library will be getting for emergency digital materials during the pandemic, explaining that the Library could easily spend that in eBooks, or else purchase some eBooks and a digital news subscription. The Trustees had no specific preference and wish the funds to be used at the discretion of the City Librarian.

City Librarian Smart changed the schedule of the holiday meeting to December 15th at 4:00 pm.

4. Friends of the Library Liaison Report

Friends Liaison reported that the Friends would be hosting a Drag Queen BINGO and hosting the Drive Through book sale, both on December 5. There will also be a virtual wine tasting, likely in February.

5. Trustees Updates

Trustee Hall is resigning the Board of Trustees as of December 1st in order to focus on the Library Foundation. She would like to serve as the liaison to the Trustees if possible.

Trustee Ziff worked on OBOC, attended the Friends meeting and Kiwanis.

Vice Chair Spears attended the SMHPS and Library lot discussions.

Trustee Hall participated in the cook book and ofrenda programs.

Chair Procter assisted with OBOC and met with the City Treasurer.

6. City Librarian Report

City Librarian Smart has been working to bring onboard the new City Council members and our little library has received many accolades, including national attention with Leila being asked to speak at the New Jersey Library Association conference.


7. Items for Future Agenda
