#### **CALL TO ORDER / ROLL CALL**

Trustees Procter, Gallagher, King, Spears, Ziff in attendance. Meeting called to order at 4:02 pm.

#### **APPROVAL OF AGENDA**

1. Kersting Court Kiosk Remodel

Communications Coordinator Tevin Voong to gave a presentation on Kersting Court Kiosk Remodel. Wanted the trustees thoughts on which historical photo should be considered to be etched in glass on Kiosk. Trustee Gallagher and Trustee Procter liked Photo #1 because it had a view of the mountains. Trustee King and Trustee Ziff liked Photo #3.

Communications Coordinator Voong said the Kiosk should be completed between late July and early August.

She was curious of the ownership of the Library Friends' building. Will it belong to the city after the remodel? Need to meet specific requirements to use for a tax exemption.

City Librarian Smart said that all the art that is gifted needs to be documented and will need to discuss the library building in the future.

Trustee Spears looks forward to discussing museums and the upcoming rock garden.

Trustee King distributed door hangers in the community.

Trustee Ziff went to Friends Annual meeting dinner. Was nice to see everyone. Helped at the book sale.

Thanked King and Trustee Ziff for all their work and volunteering for the library.

City Librarian Smart suggested to maybe open a spot for a possible Junior Board of Trustee to attend meetings. This seat could incorporate a youthful perspective into the trustees.
