#### 3. Library Donation and Donor Recognition Policy

#### 4. Library Building Update

City Librarian Smart explained the process for the Library building moving forward. There are believed to be four phases on the project this year. Those are:

- 1. Angled parking in the front;
- 2. Exterior of the Library building refresh;
- 3. Engineering of parking and ADA compliance issues; and
- 4. Building the Friends of the Library Building.

The Design of the Library Book Store space is well under way, and we are working to prepare for the other three portions to go out to bid in the coming weeks. More information will be provided as the project continues to unfold.

#### 5. Friends of the Library Liaison Report

President of the Friends of the Library, Margaret Quigley, congratulated the new board, and expressed interest in finding more members. The Friends are working towards creating a building committee for the new Book Store, and are ramping up their participation in the Partners program.

#### 6. Trustees Updates

Trustee Procter exclaimed how happy he was to be back in the Library. Trustee Adde is writing book reviews for the Friends of the Library Newsletter. Trustee Palmer attended the City

Council Meeting to support the Library's annual report, and noted that City Council was moved to tears. Trustee Spears helped with the book sale and watch the council meeting virtually.

#### 7. City Librarian Report

City Librarian Christine Smart presented how excited the Library is to be back up and running, and allowing patrons to visit. Check out of materials exceeded pre-pandemic levels in June, and we are hopeful to continue this trend.
