#### STAFF RECOMMENDATION

Close the Library on Saturday, December 24, 2022, instead of opening 10:00 am – 2:00 pm for a half day. This report is informational only and does not require further action.

#### **SUMMARY**

Not opening the library on Saturday, December 24, 2022, will reduce overall annual operating hours by four hours. The Library will close for a holiday break starting Friday, December 23, 2022.

#### **ANALYSIS**

Traditionally, the Library works a half day on December 24 with the Library being open for four hours: 10:00 AM to 2:00 PM. Over the past several years, it has been observed that December 24 is a low patron traffic day at the Library. As a result, the Library will be closed Friday, December 23 and Saturday, December 24, 2022. This is predicted to have minimal impact to Library patrons and services due to previous years' low patron use, it will also provide staff time to spend with their loved ones.
